## Detailed report of the program

Mahatma Gandhi Medical College & Research Institute, SBV in association with Internal Quality Assurance Cell Sri Balaji Vidyapeeth, conducted awareness program for the constitutional and human rights for the students and faculty of our university.

Webinar was conducted on 17<sup>th</sup> Aug 2020 with eminent speakers . The Legal officer and HR Head, SBV Mr.Ralph Mathew was the host and introduced the speakers. He gave an introduction about the rights and responsibilities of citizen. Mr.L.Swaminathan, Senior Advocate, Madras High Court spoke on the importance of Constitutional rights. He mentioned that the constitutional right can be a prerogative or a duty, a power or a restraint of power, recognized and established by a sovereign state or union of states. All constitutional rights are expressly stipulated and written in a consolidated national constitution, which is the supreme law of the land, meaning that any other laws which are in contradiction with it are considered unconstitutional and thus regarded as invalid.The Constitution guarantees six fundamental rights to Indian citizens as follows:

- (i) right to equality,
- (ii) right to freedom,
- (iii) right against exploitation.

- (iv) right to freedom of religion,
- (v) cultural and educational rights, and
- (vi) right to constitutional remedies.

The delegates were attending this event in Zoom platform and there were around 100 participants. There was good interaction between the speaker and the participants.

Mr.P.Joseph Viktor Raj, Director, HOPE, Puducherry spoke on human rights . He spoke in detail about individual rights common to most, such as equality before the law, freedom of speech and freedom of expression, religious and cultural freedom, Freedom of assembly (peaceful assembly), freedom of religion (freedom to practice religion), right to constitutional remedies for the protection of civil rights. He also mentioned that human rights in India is an issue complicated by the country's large size and population, widespread poverty, lack of proper education, as well as its diverse culture, despite its status as the world's largest sovereign, secular, democratic republic. The Constitution of India provides for Fundamental rights, which include freedom of religion. Clauses also provide for freedom of speech, as well as separation of executive and judiciary and freedom of movement within the country and abroad. The country also has an independent judiciary as well as bodies to look into issues of human rights.
