I am directed to state that the Board of Governors considered the Council Assessor's Report(s) (14.06.2019) on the standard of examination and other teaching facilities for Recognition of MD(Paediatrics) qualification for 3 seats in respect of students being trained at Shri Satya Sai Medical College and Research Institute, Kancheepuram, Tamilnadu granted by Sri Balaji Vidyapeeth's Mahatma Gandhi Medical College & Research Institute, Puducherry and Committee decided as under:-

*"The Board of Governors considered the Council Assessor's Report (14.06.2019) together with the recommendations of the PG Expert Group (BoG) and decided to recommend to the Central Government that MD(Paediatrics) qualification for 3 seats granted by Sri Balaji Vidyapeeth's Mahatma Gandhi Medical College & Research Institute, Puducherry in respect of students being trained at Shri Satya Sai Medical College and Research Institute, Kancheepuram, Tamilnadu be recognized and included in the 1st Schedule to the I.M.C. Act, 1956. The Board of Governors further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."*
