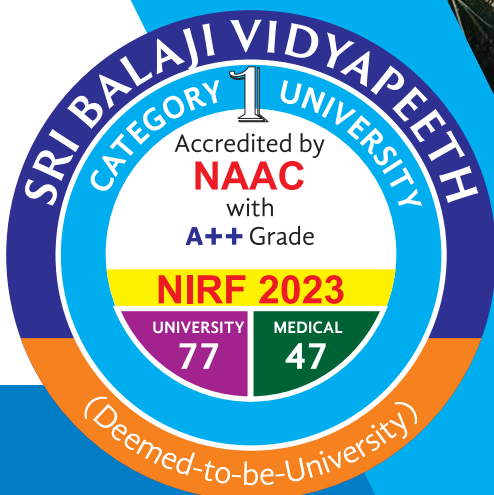

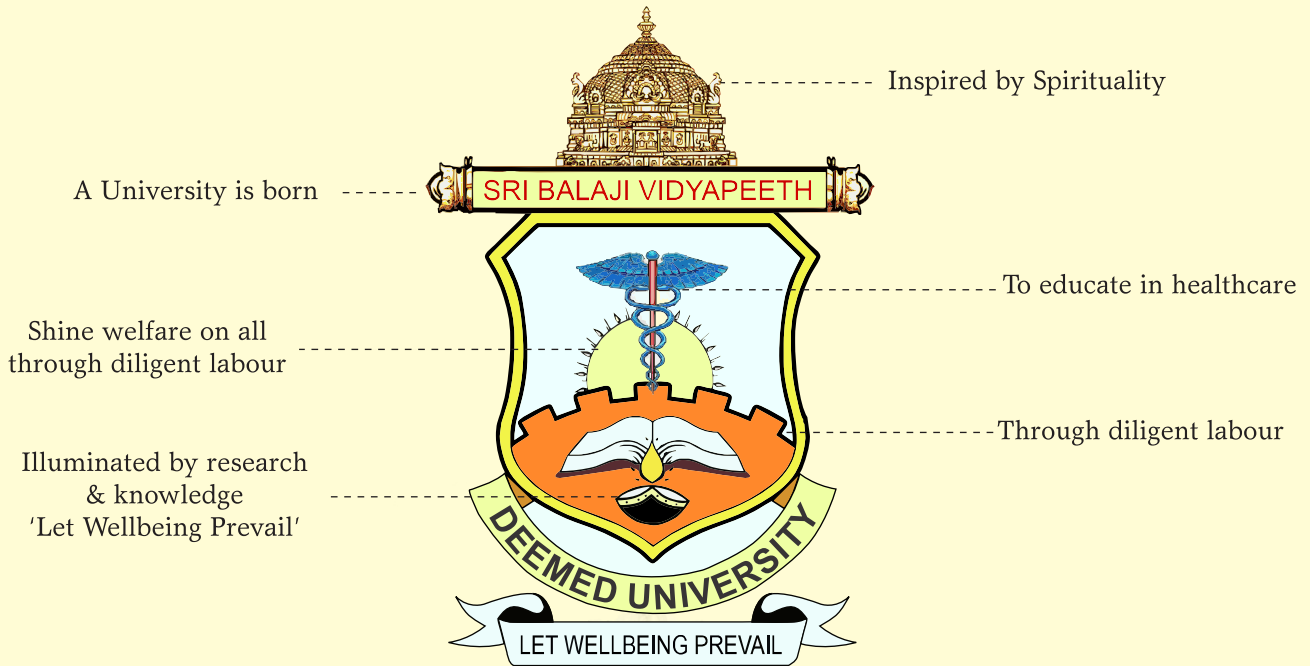

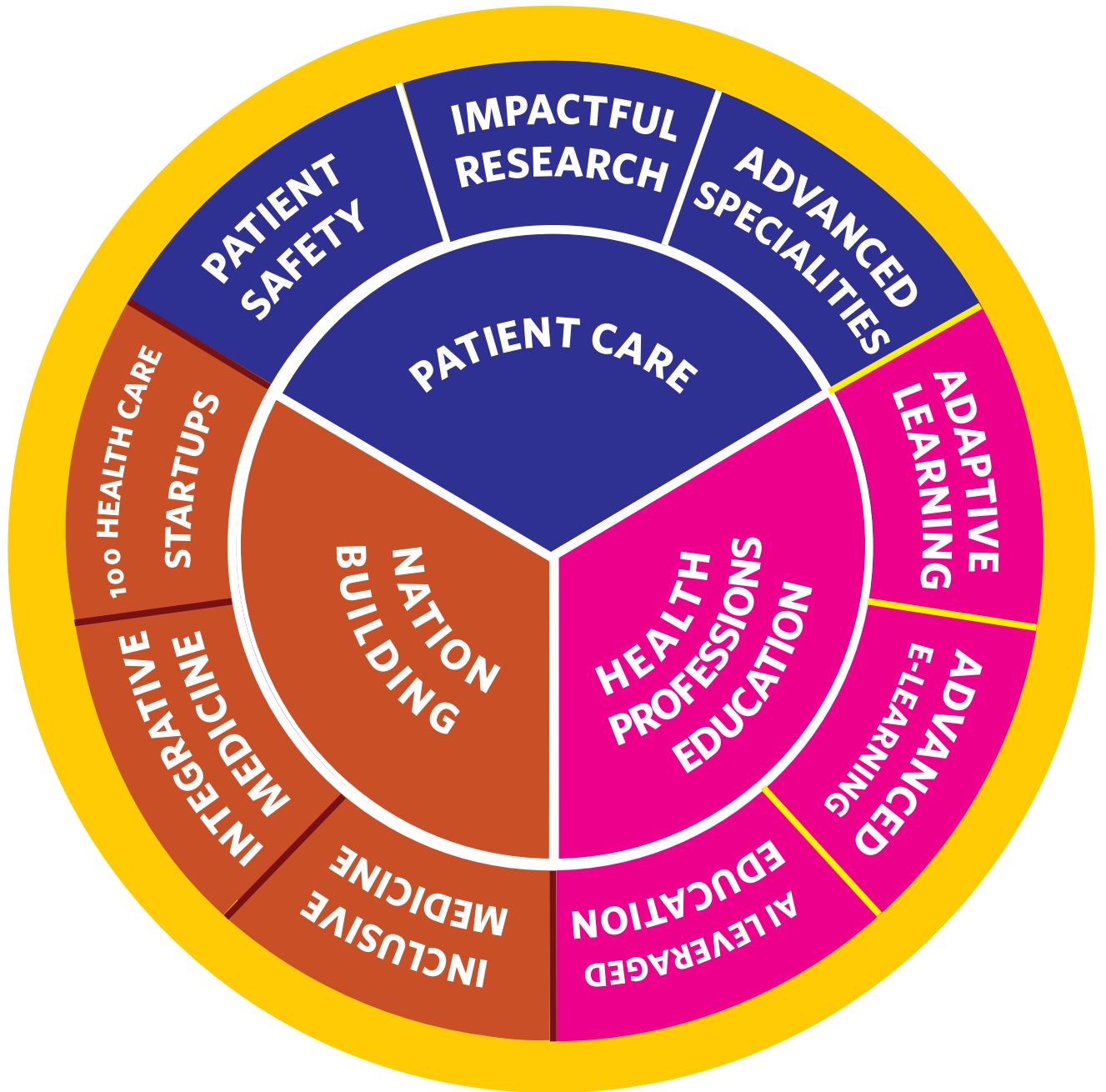

Excellence

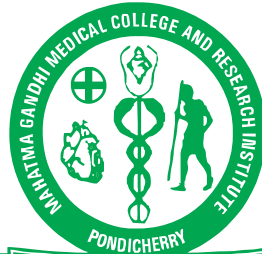

PROFILE OF HOSPITALS

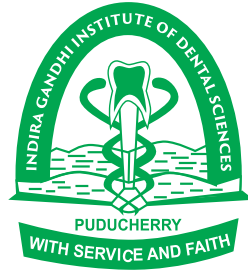

RULES AND REGULATIONS

- Ragging in any form inside or outside SBV campuses is a criminal offence and punishable as per law. Parents and the students are required to sign an undertaking to this effect. The University reserves the right to expel the students proved to be involved in ragging apart from filing criminal case against the involved students or any other perpetrator. The UGC - Toll Free Anti-ragging helpline number is: 1800 – 180 – 5522.
- The students are advised to maintain discipline and decorum inside the Hostel and also inside and outside the premises of the College and the University campuses. It is made clear that the University or the College will not be held responsible for any mis-happenings on account of any act committed by the student which is contrary to the Regulations of the University whether inside or outside the University premises.
- All students admitted in the hostels are expected to abide by the Rules & Regulations laid down for the hostel inmates. Any violation will be subject to reprehension, the Management will not be responsible for any mis-happenings or untoward incidents which occur on account of the violation of the Rules and Regulations by the students whether inside or outside the premises.
- The usage of Tobacco in any form / Alcohol / Drugs in any form / intoxicating substances in any form is strictly prohibited and punishable as per regulations.
- The students are strictly advised to adhere to the dress code provided for each of the constituent teaching units of SBV.
- Students expelled on grounds of indiscipline will not be entitled for any refund of any fees or deposit.
- The student will have to pay the annual tuition fees every year before 30th of April pertaining to the concerned academic year. A grace period of 30 days will be given to enable for payment of tuition fee with penalty i.e., till 31st May of the concerned year. Such of those students who have not paid the tuition fees as on 31st May will not be allowed to attend the classes from 1st of June.
- Students joining the institution by accepting the tuition fee as prescribed by the institution should note that the fees for all the years will be the same for the entire course. In other words the same fee paid for the first year will have to be paid for second and subsequent years also. Students joining under NRI Quota have to pay fee only in USD for all the years.
- The Fees paid for lapsed NRI Quota seats the amount will be paid in Indian Rupees equivalent to the NRI USD fees as per the order of the Fee Committee.
- The Annual tuition fees to be paid each year by the student of the respective courses will be for the period mentioned hereunder:-
 - Medical Post Graduate - 3 Years
 - Medical Under Graduate - 5 Years
 - Dental Post Graduate - 3 Years
 - Dental Under Graduate - 4 Years
 - Nursing Post Graduate - 2 Years
 - Nursing Under Graduate - 4 Years
 - Pharmacy Under Graduate - 4 Years
 - Physiotherapy Post Graduate - 2 Years
 - Physiotherapy Under Graduate - 4 Years
 - Allied Health Sciences courses Postgraduate - 2 Years
 - Allied Health Sciences courses Undergraduate - 4 Years
 - M.Sc (Medical) - 3 years

- The fees for subsequent years should be paid on or before the stipulated date.
- In case the student does not pay the tuition fees as per the Regulations, the student will not be permitted to attend classes or to sit for the examination and if there is shortfall in attendance resultant thereto, the student will have to fulfill the required attendance and thereafter in the next batch after payment of fees the student will become eligible for appearing in the examination.
- The postgraduate and Super Specialty students of constituent medical colleges of SBV will be expected to serve one year as Senior Resident in the respective departments of the institute after completion of the course. They will be paid salary as per university norms during the period of Senior Residency.
- Post Graduate students who do not pay the prescribed notified tuition fees will not be eligible to claim stipend during their posting as Residents. The Stipend will not be paid to the students of Non - Clinical subjects such as Anatomy, Biochemistry, Physiology, Pathology, Microbiology, Pharmacology and Community Medicine.
- The postgraduate students of the constituent colleges and the Super Specialty students will be required to publish their dissertations within one year after the completion of their course, SBV will reserve the right to publish them.
- All students are advised to refer the prospectus of the University and familiarize themselves with the details pertaining to their admission, fees and study. They are also required to check the SBV website (www.sbv.ac.in).
- All students are required to collect the Handbook for medical students for the policy guidelines and also the disciplinary Committee Manual on payment of the fixed charges.
- All students shall submit their original academic and personal certificates, like mark sheets, school leaving certificates and other such documents at the time of submitting Admission Form along with self-attested copies for verification.
- In case of any suspicion over the authenticity or genuineness of a certificate, reference shall be made to the University or the Board which issued the certificates to the students and admission will be subjected to the authentication.
- Students admitted in any of the programmes shall complete the programmes within the stipulated course period that has been notified by the respective Statutory Body/SBV Regulations.

Hostel Accommodation ●

Separate hostels are available for male and female postgraduates. The rooms are fully furnished, with air-conditioning, hot water geysers, student Wi-Fi and other amenities. The hostels feature common areas with reading halls, gym, theatre, playgrounds for football, hockey, cricket, volleyball, basketball & lawn tennis, etc.

Stipend ●

The Medical Postgraduate programs are conducted in accordance with the Regulations of the National Medical Commission. Selected candidates will be paid a consolidated stipend as per Regulations.

Non-stipendiary courses : 1. Anatomy 3. Physiology 5. Pharmacology 7. Community Medicine
 2. Biochemistry 4. Microbiology 6. Pathology 8. Forensic Medicine

Note: Stipend will be paid only upon receiving the Annual Tuition Fees, Hostel Fee & Other Fees in toto for the concerned academic year.

Examinations ●

The student will be issued hall tickets for the University Examinations and allowed to sit for the examination only after the full fees is paid.

For the students admitted through NEET ●

For the programmes where admissions are made through NEET and are governed by Medical Counseling Committee Regulations, the students are not allowed to withdraw after the Second round of counseling conducted by Directorate General of Health Services (DGHS), Government of India. If they do so, they will not be eligible for refund of the Tuition fees paid and the student will be liable to pay the annual tuition fees for the remaining period of the entire course before relief in the event of the seat remain vacant. Processing fee of Rs.50,000/- or whatever is applicable for that year will be charged as the processing charges from PG student and Rs. 25,000/- for UG Students in such situations as per Regulations.

All the students and their parents will be required to sign individual undertakings pertaining to fees, other fees, hostel and acceptance of Regulations of SBV. All should strictly abide by the undertakings signed. It is to be noted that the undertakings signed cannot be challenged.

The students who do not clear their pending tuition / other / hostel fees are not liable to receive their degree certificates until the dues are cleared.

All disputes are subject to the respective regional jurisdiction of the concerned constituent unit only.

For the students not admitted through NEET ●

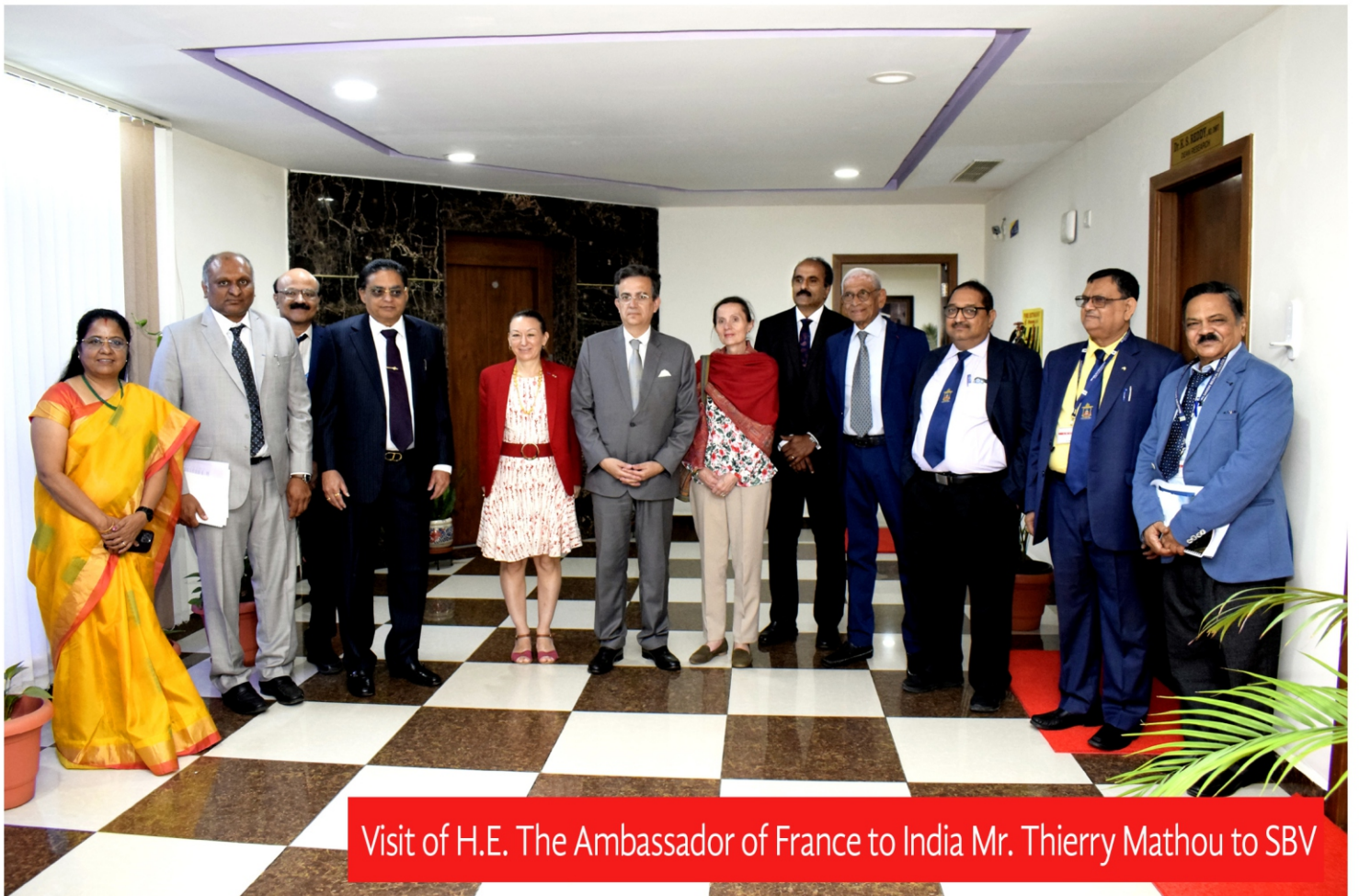
If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution concerned shall follow the procedure provided by the University Grants Commission (UGC) for refund of fees remitted by the student. The students are advised to go through the relevant UGC Regulations.

Processing fee of Rs.15,000/- (Rupees Fifteen Thousand only) will be charged as processing charges from the student in such situations as per Regulations.

·In case the student leaves the course anytime beyond 30 days from the notified last date of admission and if the seat is vacant for this reason, the student will also be liable to settle the tuition fees for the entire remaining course period.
